EDEKT S.A., recognizing the importance of responsible investment decisions based on ESG criteria, joined the "Principles for Responsible Investment" (PRI) initiative as "Investment Manager Signatory", with the guidance and support of the specialized consulting firm Global Sustain. PRI is the most recognized and accredited initiative for the promotion of responsible investments and the integration of ESG criteria into investment decisions in a global level, created with the support of the United Nations. Today, PRI lists more than 3,500 companies and organizations with over USD 100 trillion AuM.

As a UN-supported PRI signatory, EDEKT S.A. adopts the following principles of responsible investment:

- Incorporation of ESG issues into investment analysis and decision-making processes.
- Active ownership and incorporation of ESG issues into our ownership policies and practices.
- Seeking of appropriate disclosure on ESG issues by the entities in which the company invests.
- Promotion of acceptance and implementation of the Principles within the investment industry.
- Collaboration for enhancing our effectiveness in the implementation of the principles.
- Submission of a Transparency Report on our activities and towards implementing the principles.
